## Aims

This day-and-a-half training and advocacy session aims at providing the participants with a specialized knowledge of the mechanisms of the Council of Europe European Social Charter and of the most recent trends in the case-law of the European Committee of Social Rights. The training is addressed to international and national non-governmental organisations, employers' and workers' unions, lawyers advising these organisations or wishing to invoke the Charter more systematically before national authorities, and public servants. The programme includes both plenary sessions and smaller working groups, in order to ensure that all those attending receive the focused presentations they are most interested in.

## Day 1 – 18 January

9.30 to 10.30 AM

**Introduction (plenary)**: Olivier De Schutter (UCL, ANESC)

Historical development of the ESC: what is unique to the ESC and what have been the results of its revitalization? How does its effectiveness compare to that of the European Convention on Human Rights and to that of the EU Charter of Fundamental Rights in the EU?

The obligations of States under the ESC: how useful is the ESC as tool in the hands of social actors? What impact does the ESC have on European Community Law?

**The Procedure of the ESC (plenary)**: Gerard Quinn (former member, European Committee of Social Rights), Gisella Gori (Secretariat of the European Social Charter), and Stefan Clauwaert (ETUI-REHS) for the role of the ETUC in the procedure

Reporting by States and the input of social partners and NGOs: what may unions and civil society organizations gain from participating?

Collective Complaints: what may we expect from these procedures and how difficult are they to file? which costs are involved? Which expertise is required?

Application of the ESC at the national level : how can the ESC be used before national authorities, judicial, administrative or political ?

The requirement of non-discrimination in the ESC, with a special focus on persons with disabilities, the Roma, and other ethnic minorities

Freedom of association, the right to collective bargaining, and the right to consultation within the undertaking

The overall introduction will be followed by the discussion around case-studies proposed by the European Network Against Racism (ENAR), on the following issues:

- Access to Education for Roma, Sinti and Traveller communities (there are a whole range of contexts);
- Issue of children in asylum detention center in Denmark.

Health and safety at work and the right to vocational guidance and training

**Working group II (other issues)**: Wouter Vandenhole (Katholieke Universiteit Leuven and Tilburg University)

The right to protection against poverty and social exclusion and the right to housing

The presentations of these questions will be followed by the discussion around case-studies proposed by the European Network Against Racism (ENAR) and the European Federation of National Organisations Working with the Homeless (FEANTSA), on the following issues:

- introduction of restrictions to social welfare in Ireland (Habitual Residence Condition) following EU accession in 2004;
- access to housing provision, leading to homeless new of new migrants in the UK and Ireland;
- the right to health for homeless persons
